Basic book citation format. The APA in-text citation for a book includes the author's last name, the year, and (if relevant) a page number. In the reference list, start with the author's last name and initials, followed by the year. The book title is written in sentence case (only capitalize the first word and any proper nouns).

Cite your sources both in-text and at the end of your paper. For in-text citation, the easiest method is to parenthetically give the author's last name and the year of publication, e.g., (Clarke 2001), but the exact way you cite will depend on the specific type of style guide you follow.

Remember that for an in-text (parenthetical) citation of a book with no author, you should provide the name of the work in the signal phrase and the page number in parentheses. You may also use a shortened version of the title of the book accompanied by the page number.

Using In-text Citation Include an in-text citation when you refer to, summarize, paraphrase, or quote from another source. For every in-text citation in your paper, there must be a corresponding entry in your reference list. APA in-text citation style uses the author's last name and the year of publication, for example: (Field, 2005).

“Second Edition,” “Revised Edition”) is stated on the cover and/or title page of the book, it should be included in your citation. Edition information is always abbreviated and followed by a period (e.g. “2nd ed.” or “rev. ed.”).

Academic papers in APA citation has general writing guidelines. Papers should be typed, double-spaced on standard-sized paper (8.5" x 11") with 1" margins on all sides. You should use a clear font that is highly readable. APA recommends using 12 pt. Times New Roman font.
