Clinical diagnosis is the process of using assessment data to determine if the pattern of symptoms the person presents with is consistent with the diagnostic criteria for a specific mental disorder outlined in an established classification system such as the DSM-5 or ICD-10 (both will be described shortly). Any diagnosis should have clinical utility, meaning it aids the mental health professional in determining prognosis, the treatment plan, and possible outcomes of treatment (APA, 2013).

For example, a comparison of ICD-10 and the Composite International Diagnostic Interview (CIDI) suggests that two or three times as many psychiatric diagnoses as the clinician would assign in routine diagnostic assessment are revealed by standardized instruments ( Baldacchino and Crome, 2010 ).
