An S-110L Application for Certificate of Manufactured Home Ownership is processed at the branch office. The fee for an original or transferred mobile home title is \$90. ## Oregon Secretary of State Administrative Rules

1. DO NOT sign a blank form. 2. If your Certificate of Mobile Home Ownership is NOT received within 60 days, contact a Secretary of State office. 3. The Dealer must provide the purchaser a copy of this application after the sales tax and Certificate of Mobile Home Ownership fees have been paid.

### DSPS Manufactured Homes Titling Program

Manufactured Homes require that certain documents related to an application for a certificate of title for a Manufactured Home be filed and recorded by the County Clerk and Recorder. A Certificate of Permanent Location, which is used when the Manufactured Home is permanently affixed to the ground.
