In May 2018, the NMC published its long-awaited Standards of Proficiency for Registered Nurses (NMC, 2018a), which identifies the main aspects of registered nurses 'roles, responsibilities and accountabilities. The required proficiencies are structured around seven areas (Box 1).

NMC guidelines require the mentor to be available to the student for at least 40% of the time they spend on placement. Students can also spend time during their placement with other clinicians and linked services, which is a great way of ensuring that they have a varied and multi-professional experience.

The NMC has changed the way mentoring works by splitting the role of the mentor into supervisors and assessors. Also, the new education standards remove the cap on simulated practice hours. By doing so, the NMC believes that it will be easier for nurses and midwives to return to practice.

Nmc Guidelines For Mentoring Students

The NMC Standards require that at least 40% of practice time mentors/ practice teacher must be available to nursing students. The practice teacher is also required to meet this 40% target when mentoring registered nurses that are undertaking a post-registered course that leads to an NMC registration.
