All examples follow APA style rules. Note that APA papers tend to include few direct quotations, as paraphrasing is the preferred method of citing sources. Quotations are normally reserved for definitions, to capture an author's apt phrasing, or to interact with the specific wording of the source (Publication Manual of the American Psychological Association, 8.25). For every in-text citation in your paper, there must be a corresponding entry in your reference list. APA in-text citation style uses the author's last name and the year of publication, for example: (Field, 2005). For direct quotations, include the page number as well, for example: (Field, 2005, p. 14).
